General Information, Credentials, Terms and Conditions for Submitting Tenders:

1. Validity of Tender:

Tender shall remain valid for 180 Days from the date of opening of tender.

2. Eligibility of Tenderer & Qualification:

- Publishers/Authorized Distributors/Direct Importers/ Books Sellers having at least three years' experience for supply of Medical Books/ Scientific/ Technical to Medical College Libraries at any State Government or Government of India or any Indian Libraries are eligible for quoting.
- Bidders who are in a position to supply at least 80% or above the required quantity of book will be treated eligible to participate in the tender.
- The Bidder(s), to qualify for the award of contract, shall have to submit a written power of attorney authorizing the signatories of the bid to participate in the bid.
- The Bidder(s) shall submit full details of his agency/ firm or, if the Bidder is a proprietorship/ partnership or a Private Limited Company, full details of ownership or name of the Director.

3. Documents Downloading:

Intending Bidder(s) may download the tender documents free of cost from the website: <https://wbtenders.gov.in> directly with the help of Digital Signature Certificate (DSC). The tender Documents may also be downloaded from the <https://www.wbuhs.ac.in> and <https://comjnmh.ac.in> website.

4. Earnest Money Deposit (EMD):

- The tender will have to be submitted under the existing orders of the Government of the West Bengal & must accompanied with Earnest Money Deposit of ₹30,000.00 (**Rupees Thirty Thousand Only**) Electronically (**ONLINE MODE**) only as detailed in Government of West Bengal, Finance (Audit) Department **Memo No. 3975-F(Y) Dated: 28th July, 2016**.
- For successful bidder it will be released after expiry of the tender period. It means EMD will be treated as Performance Security Deposit.
- EMD** will be returned to the **Unsuccessful Bidder** through Online Mode. **No interest will be paid on the EMD.**
- The *Earnest Money* of the Bidder/ Bidders will be *liable to forfeiture* if the *bidder withdraws or impairs or derogates from the tender process* as a whole or for any particular item or items at any stage after the opening of the tender, or fails/ refuses to enter into written agreement for any of all the items of his accepted tender within the time specified when requested to do so or face to furnish necessary Security Deposit with in the stipulated time, if any.

Improper filling, suppression of facts, false statement while information given at Annexure-VI [List of Medical Books available in ready stock] will lead to disqualification and penalty in the form of permanent blacklisting.

B) “BID B’: Financial Cover: - BOQ

The folder as “**Financial Bid**” shall contain in **Excel File**. It is expected that rate per Unit item would be Publisher’s Price List/ Catalogue Price and shall be in INR (Indian Rupees) only. The Firm shall quote discount percentage per unit item on that Publisher’s Price List/ Catalogue Price of Medical Books at the BOQ.

7. Evaluation of Tender:

During the tender evaluation process, the Technical Bid will be opened first. Technical Bid will be evaluated by the **Technical Bid Evaluation Committee**. The Financial Bids of those qualified in Technical Bid will be opened only. The Financial Bids of those bidders failing in Technical Bid will not be opened and shall be rejected. The Bidder offering the specified item(s) at the lowest rates will only be selected as L1.

8. Terms and Conditions of the Tender:

a. Rate:

- i. Rate of each book shall be quoted. Rates should be inclusive of all Taxes, Custom duty, Insurance, Cess, Levy, Octroy, Royalties, Transportation, Loading-Unloading, Packing Charges, and Stacking etc. & all other incidental charges therein. No other charges will be allowed beyond the quoted rate(s).
- ii. Tenderers should quote rate of discount (in percentage) offered on Publishers’ Printed Rate (Catalogue Price) as per enclosed Annexure-VI list (at least minimum) at the BOQ. Documentary evidence from Publisher /distributor will have to submit. *The Principal, College of Medicine & JNM Hospital, WBUHS, Kalyani, Nadia is not bound to accept the highest discount or any tender and also reserves the right of rejecting all or any of the tender without assigning any reason.*

All payments will be made in Indian Rupees only.

- iii. Rates quoted shall be valid for entire period of the contract and no revision of rate(s) should be allowed.
- iv. In no cases Tender Inviting Authority (TIA) shall pay the higher rate than printed rates irrespective of quoted/agreed rates.
- v. If rate of any item is in fraction then it will be nearest rounded figure, i.e. 0.50 or above will be calculated to next rupee and below 0.50 will be ignored.

b. Selection of Bidder:

- i. Supply order will be issued to L1 Bidder (s). L1 Bidder(s) will be selected on the basis of ***lowest amount offered against*** items mentioned in BOQ on the basis of ***Item Wise (form base)*** tender. Financial Bid notes may be looked into.
- ii. Bidder(s) must rate for the books as mentioned at the BOQ, otherwise bid will be stand cancelled. Rate of BOQ is in INR (Indian Rupees) only.
- iii. *In case of dissatisfaction, the TIA reserves the right to disapprove the offer of L1 bidder and go for the next lowest bidder.*

- iv. Principal, College of Medicine & JNM Hospital, WBUHS, Kalyani, Nadia will not take any responsibility for the delay in submission of bid caused due to non-availability of Internet Connection, Traffic Jam etc. for the Online Bid(s).
 - v. The attempt on the part of the vendor to influence the Authority to whom the tender is being submitted or the **Tender Accepting Authority** will make the vendor liable for exclusion from the consideration of his tender.
 - vi. No tender may be withdrawn in the interval between the deadline for submission of tender and the expiry of the period of tender validity. Withdrawal of tender during the interval may result in the Bidder's forfeiture of Earnest Money Deposit.
 - vii. The successful Bidder shall not in any case sublet the contract in full or any part of it to third party.
 - viii. The tenders not submitting any or all of the aforesaid requirement(s)/ document(s) shall be rejected.
 - ix. Conditional tenders are liable to be out-rightly rejected.
 - x. The pre-qualification documents (Technical Bid) will be opened by the Tender Inviting Committee in presence of the Bidders available and present at as per time scheduled.
 - xi. Financial Bids will be opened only after the formalities of opening of **Technical Bids** are completed and will be notified latter.
 - xii. Bidders will have to present original requisite documents in support of uploaded documents for verification, if asked for.
 - xiii. In case it is found that two or more bidders have quoted same price for any item, the lowest bidder will be selected by the procedure adopted under **Memo No. 2320-F(Y) Dated: 07.06.2022 of Finance Department (Audit Brach).**
 - xiv. E-Tender should be addressed to the Principal, College of Medicine & JNM Hospital, WBUHS, Kalyani, Nadia. Bidders may download tender documents from the websites: <https://wbtenders.gov.in>. & <https://wbuhs.ac.in/>
 - xv. Any subsequent notice regarding this tender shall be uploaded in the above websites only
- c. Period of Contract:**
- i. The item wise contract will be valid for a period of 1(One) year at 1st instance and thereafter it shall be further executed (Renewed) for another suitable spell of period(s) on the furnishing amount vis-a-viz, depend upon the quantum of supply actually received and subsequently recovered.
 - ii. There will be no sub-letting during the period of contract as mentioned earlier.
- d. Agreement and Performance security deposit :**
- i. The successful Bidder, will have to execute a formal "Agreement" with **the Principal, College of Medicine & JNM Hospital, WBUHS, Kalyani, Nadia** at a "Non-judicial Stamp Paper" worth ₹ 100 (Rupees One Hundred Only) within 15(Fifteen) working days from and after receiving the "**Letter of Acceptance**" and will purchase one set of Tender Documents @ ₹ 1,000 (Rupees One Thousand Only) each set from the Accounts Section of this Office, duly signed and submit to this institute which will be treated as part of "**Agreement**". The Payment for documents shall be made through ONLINE MODE only.
 - ii. The contractor will be required to contact the "Central Store" of this institute to supply of the books.
 - iii. In case of violation of the terms and conditions of the contract, the Performance Security Deposit will be forfeited.

- iv. The Performance security money (herein converted EMD) as deposited will be returned after the contract period, ***no interest will be paid against this Performance Security Deposit Money.***
- v. The selected firm should enclose a certificate in Annexure-V, that it has not been black-listed by any Government Office/ PSU/ Semi-Government Office/ Autonomous bodies.
- vi. All terms and conditions as mentioned above will have to be accepted by the bidder(s).

e. Order, Supply & Delivery Schedule:

- i. Delivery of books at the Central Library of the TIA will be free of cost & shall be completed by the Supplier in accordance with the specified period mentioned by the authority at Supply Order. The supplier/ or his authorized representative will remain present while delivery of books to library till all checking formalities are over by the library.
- ii. *Medical Books:*
 - 1. Medical Books available in India must be delivered within 30(thirty) days of placing of order. In-case books imported from foreign publishers, the supplies should be completed within 45(Forty-Five) days from the date of purchase order.
 - 2. *The supplier has to supply all the book(s) as specified at Annexure- VI with the Bid Documents and as placed in the purchase order preferably in one lot. Part supply will not be entertained.*
- iii. *In case of any title (book) is not available (out of print), the supplier has to furnish the certificate from the Publisher's concerned regarding the non-availability/ out of print of such books.*
- iv. The latest edition/ printing of books shall be supplied. Where edition is not mentioned, latest edition will have to supply & a status report of the edition from the Publisher should be produced. Preference may be given for the library edition books, if available. All the books of same title should have the same year of printing; variation of the year of printing will not be accepted.
- v. *The Books are to be transported in such packaging so that there will be no damage to the primary packaging during the transportation process.*
- vi. Demand may be increased or decreased depending on demand on future. Bidder will have to consider the same while bidding as supply of the enhanced quantity will be mandatory as the original one.
- vii. *Authority may impose penalty for delaying supply as well as supply of old and defective consignment & part thereof and those book(s) must be **replaced** by the supplier at its own expenses with in stipulated time and as per direction of the authority,* failing which the supplier may be debarred from participation in the coming year's tenders.

f. Inspection:

Medical Books will be accepted only after inspection by the Principal, College of Medicine & JNM Hospital, WBUHS, Kalyani, Nadia or by his authorized person(s).

g. Payment of Bill:

- i. *No advance payment shall be paid.*
- ii. On being selected the successful vendor will have to submit one application to the Principal, College of Medicine & JNM Hospital, WBUHS, Kalyani, Nadia stating the name of the payee/ recipient, Bank Account Number with IFSC Code, Contact Number for making payment. Payments against the bill claim will be released subject *to, completion of supply at the Central Library and verification of books by the Librarian(s)* and to the satisfaction of the Principal, College of Medicine & JNM Hospital, WBUHS, Kalyani, Nadia.

- iii. Bills/ Invoices are to be submitted in triplicate (Computerized only) in original mentioning the Full Title of the Book, Author, Edition, Year of Publication, Price of books, percentage of Discount, Number of copies, and Net Price, in the name of the Principal, College of Medicine & JNM Hospital, WBUHS, Kalyani, Nadia for payment.
- iv. A certificate should be appended by the supplier on the body of the Bill/ back side of the bill (Last page) under the signature and seal as follows:-

“This is to certify that:

- *Books are supplied as per order no Dated of the Principal, College of Medicine & JNM Hospital, WBUHS, Kalyani, Nadia.*
- *Books are supplied in good condition.*
- *Books are supplied only latest edition/ latest year of publication and are not old edition.*
- *Prices of the books are charged correctly in accordance with the publisher's catalogue price only.*
- *Prices charged in the books/ bill, if any found excess later on are subject to recovery from the supplier.*
- *Books supplied, if any found misprint/ damaged/ page missing/ old edition are subject to replacement.”*

- v. Payments against the bill claim will be released subject to availability of fund and checking of the following documents:-
 - 1. Supplier's Bills/ Invoice in original triplicate (Computerized only)
 - 2. Photocopy of supply order.
 - 3. Any other importance documents on the discretion of College Authorities.
- vi. No financial claim in case of any delay in payment will be entertained. No bidder can disrupt/ hamper the supply of books as requisitioned on the basis of non- payment of bills/ delayed payment of bills. This non-payment of bills/ delayed payment does not confer any legal or other right on the firm to proceed against the office.
- vii. The payment will be made after statutory deductions from the bill as per existing/ applicable rates, rules.
- viii. Payment shall be made in Indian Rupees by RTGS/ NEFT to the account provided by the supplier (L1 Bidder).
- ix. In case of any defective supply(s), the cost of replacement shall be deducted from the immediate payment due, if not replaced by the supplier within stipulated time.

h. Penalty & Termination:

- i. For Delays:- If the supplier fails to supply Books as per Purchase Order within the time period specified in the contract, the purchaser shall deduct from contract price a sum equivalent to 0.50% of the price of delayed items each week of delay or part thereof until actual delivery up to maximum of 10%. Once the maximum reach the purchaser may consider termination of the contract.
- ii. Authority may impose penalty for supply of defective consignment & part thereof and those Book(s) must be **replaced** by the supplier at its own costs within stipulated time and as per direction of the authority.
- iii. Any delays must be communicated to the Authority in advance. If the suppliers fails to supply the requisite item(s) on time or dishonors the contract in any way, the contract awarded shall be liable for outright cancellation/ termination, without assigning any reason thereof, and the security deposit and the payment due, if any shall also be forfeited. The authority is free to entrust the job to any other firm/ party as the risk and expense of the defaulting supplier.

The decision of the "Tender Inviting Authority" will be final and binding on the defaulting supplier.

- iv. Principal, College of Medicine & JNM Hospital, WBUHS, Kalyani, Nadia reserves the right to cancel/ terminate the contract at any time if the supplier adhere to the terms and conditions stated herein if the supply of books is not satisfactory, don't meet the specified requirements and complaints received regarding the print quality during the contract, without assigning any reasons thereof.
- v. Any misbehavior from the authorized person of the suppliers during service shall be viewed seriously and may cause Termination of Agreement.
- i. **Bidders who have already applied for the 1st Call & 2nd Call tender, are also have to upload documents afresh i.e. all documents should be prepared after notification of 3rd Call e-tender.**
- j. **Resolution of Disputes:**

In case of a dispute or difference arising between supplier and purchaser relating to any matter arising out of or connected with the contract, such dispute and difference shall be restricted to jurisdiction of Courts in Kolkata only, if first attempt to resolve any dispute or difference through good faith negotiations fails.

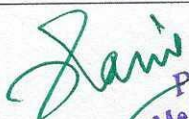
